

132.400 Bond of property valuation administrator.

Before entering upon the duties of office, the property valuation administrator shall execute a bond conditioned upon the faithful performance of the duties of the office with a surety to be approved by the Department of Revenue. In counties containing a city of the first class or consolidated local government, the bond shall be in the sum of one hundred thousand dollars (\$100,000); in counties containing a city of the second class, fifty thousand dollars (\$50,000); in all other counties, twenty thousand dollars (\$20,000).
