§ 1236. Penalties for violations of regulations

For any violation of regulations issued pursuant to sections 1233 to 1235 of this title the following penalties shall be incurred:

- (a) A licensed officer shall be liable to suspension or revocation of license in the manner now prescribed by law for incompetency or mis-
- (b) Any person in charge of the navigation of a vessel other than a licensed officer shall be liable to a penalty of \$5,000.
- (c) The owner of a vessel (including any corporate officer of a corporation owning the vessel) actually on board shall be liable to a penalty of \$5,000, unless the violation of regulations shall have occurred without his knowledge.
- (d) Any other person shall be liable to a penalty of \$2,500.

The Commandant of the Coast Guard is authorized and empowered to mitigate or remit any penalty herein provided for in the manner prescribed by law for the mitigation or remission of penalties for violation of the navigation

BCHAPTER I—RESEARCH AND RELATED **PROGRAMS**

Restoration and maintenance of chemical, physical and biological integrity of Nation's waters; national goals for achievement of ob-

he objective of this chapter is to restore and intain the chemical, physical, and biological egrity of the Nation's waters. In order to lieve this objective it is hereby declared that, sistent with the provisions of this chapter—

(1) it is the national goal that the discharge pollutants into the navigable waters be liminated by 1985;

(2) it is the national goal that wherever atainable, an interim goal of water quality hich provides for the protection and propagaon of fish, shellfish, and wildlife and provides or recreation in and on the water be achieved by July 1, 1983;

(3) it is the national policy that the discharge of toxic pollutants in toxic amounts be prohibited;

(4) it is the national policy that Federal financial assistance be provided to construct publicly owned waste treatment works;

(5) it is the national policy that areawide waste treatment management planning processes be developed and implemented to assure adequate control of sources of pollutants in each State:
